The highlight of the year was no doubt the opening of the Australian Embassy in Bern, an event held at the Zentrum Paul Klee in the Swiss capital on Friday, 9th December.

Relations between the two countries date back to 1961 when Switzerland opened an embassy in Australia. Since then, Australia has become home to the third largest Swiss community overseas (around 26,000 people!). Over 250 Swiss companies are operating in Australia with the alpine nation being its eleventh largest investor.

Guest speakers included: Sen the Hon Don Farrell, Australian Minister for Trade and Tourism; Federal Councillor Guy Parmelin, Swiss Minister of Education, Economics and Research.
