responsible business conduct



On 8th June 2023, the OECD launched updated <u>Guidelines for Multinational Enterprises on Responsible Business Conduct</u> which provide a comprehensive set of responsible business conduct standards covering topics such as human rights, the environment, use of technology, anticorruption and more.

The Guidelines provide useful advice on where companies should focus their due diligence efforts when they operate internationally. While the Guidelines are voluntary for multinational companies to follow, the Australian Government expects multinationals operating in Australia, or headquartered in Australia, to adhere to them, including the need for a human rights policy and to conduct human rights due diligence.
